### **CONFERENCE OVERVIEW**

The inaugural **Building Bridges, Changing Lives** conference is being convened by Partners in Justice, a project of The Arc of NC and the NC Council on Developmental Disabilities. The conference will provide vital information on the issue of people with intellectual disabilities who become involved with the criminal justice system.

*For the first time ever in North Carolina*, professionals from the criminal justice and human services systems will join together to explore ways to ensure that people in both systems have the necessary knowledge to assist people with cognitive disabilities when they become involved with the criminal justice system. National, state and local experts from both criminal justice and human services professions will present keynote addresses and lead interactive workshops during the one-day conference.

The primary goal of this *groundbreaking* conference is to assemble a distinguished front line experts and professionals with a focus on networking and brainstorming on how to secure equal justice for people with cognitive disabilities and ensure the safety of the community and all of its citizens. Significant issues will be addressed and recommendations for local, regional, and state policy changes will be explored.

### **ATTENDEE PROFILE**

The conference is designed for professionals employed at all areas, levels, and disciplines involved in the criminal justice process – investigation, arrest, bond, defense proceedings, trial, sentencing, probation/parole, incarceration, and release to the community. Human services professionals, people with intellectual disabilities and their families will also be included.
